As Baldrige and EFQM Criteria and its variations customized to meet the needs of various economies is widely used criteria for National Quality Awards. The GPEA Applicants must submit their application form attached with the Feedback report / or site visit report addressing the BE criteria according to the Business Excellence Awards requirements in their country.

Applications are limited to application report with no additional documents. However, feedback report and recommendations letters are accepted as necessary supporting documents. Additional information on performance and best practices are required on the prescribed format to support the application if the specified years are not covered by the application report.

APQO Award Governing Council

Comprise representatives mainly from APQO Executive Board & Core Council. The APQO Award Governing Council (AAGC) sets and review standards and guide the adoption of proven practices and processes ensuring rigour and currency in the BE Models and adoption by organizations in countries across the world. It also provides an oversight to the assessment practices that comply to desired standards and are value adding to applicants from APQO member countries or other interested parties.

APQO Award Governing Council 2025

The council will comprise the following APQO Officers:

- Vice President Awards APQO
- President Elect APQO

- Subject matter expert / Past President as required based on recommendation by President, Vice President Awards & Vice President Administration

GPEA Assessors

GPEA Assessors are experienced Assessors recommended by active APQO Core Council Members and with assessment experience in assessing National Quality Awards applicants in various countries. Amongst them are assessors from Global Excellence Models Council (GEMs) Members who actively provide support and guidance to ensure processes and standards adopted are validated practices of leading Business Excellence Models and existing practices amongst GEMs member countries. Assessors operate as team and submit assessment findings to GPEA Secretariat for collation. Findings and recommendations are deliberated for decision by the APQO Award Governing Council.

The 2025 GPEA Awards Cycle

- Submission of GPEA Applications - **15th December 2024 to 28th February 2025**
- Assessment - **March to May 2025**
- Secretariat Collation - **May to June 2025**
- APQO Award Governing Meeting - **July 2025**
- Announcement of Results - **July 2025**
- GPEA Awards Night - **14 - 17 October 2025, Beijing, China**

Key requirement to comply/note:

- 1) All Applicants are required to submit the following when submitting the application:
 - a. Full name & full designation of Highest Ranking Officer of the applicant Organization
 - b. A soft copy of photograph of CEO / Highest Ranking Officer – to be in high resolution
 - c. Logo of the Organization – to be in high resolution
 - d. Between 100 to max 120 words on applicant's profile
 - e. Website address
- 2) All winners must participate the award ceremony to receive the award. No arrangements for third party receive the award or request send the award through third party is permitted. In the event a winner do not participate in the GPEA Award ceremony, the award will be withdrawn by the APQO Award Governing Council.
- 3) The APQO Award Governing Council decision is final and no appeals will be allowed.
- 4) It is very important the applicants provide the necessary information in submitting a complete and accurate information for GPEA application in terms of eligibility requirements, the application and the complete set of summary of performance information required.
- 5) Applicants are to submit letter of recommendation from the National Quality Award Body in their countries and also to provide the necessary information of the various award categories as per the National Quality Award program in their countries.
- 6) Applicants are requested to seek support in endorsing their GPEA application by Active APQO Core Council Member from their countries.
